The Director of Rural Development and Panchayat Raj in his letter read above, has sent a proposal recommending reimbursement of an amount of Rs.7,34,81,596.00 (Rupees Seven crores thirty four lakhs eighty one thousand five hundred and ninty six only) based on the claims made by the Tamil Nadu Civil Supplies Corporation Limited, towards transportation charges and other expenditure for movement of 1,14,738 MTs of rice from Food Corporation of India godowns to the taluk godowns allotted to Tamil Nadu under Sampoorna Grameen Rozgar Yojana for the year 2006-07 (Ist instalment release).

- 2. The Government after careful examination, have decided to accept the proposal of the Director of Rural Development and Panchayat Raj in para 1 above and accordingly, sanction and release an amount of Rs.7,34,81,596.00 (Rupees Seven crores thirty four lakhs eighty one thousand five hundred and ninty six only) towards the payment of transport charges and other expenditure for the movement of 1,14,738 MTs of rice supplied under Sampoorna Grameen Rozgar Yojana during the year 2006-07 (Ist instalment release) to the Tamil Nadu Civil Supplies Corporation Limited, Chennai.
