ORDER:

In the G.O. first read above orders were issued for the redeployment of 6 posts as Personal Assistant (NMP) as District Project Officers to implement the Project of National Disaster Risk Management in Tiruvallur, Kancheepuram, Cuddalore, Nagapattinam, Kanniyakumari and the Nilgiris Districts.

In the letter third read above, the Principal Secretary and Commissioner of Revenue Administration, has stated that National Disaster Risk Management Programme was concluded by 30.06.2009 and the staff made available at the Districts are withdrawn from 01.07.2009. The Commissioner of Rural Development and Panchayat Raj has, therefore, requested to cancel the orders of redeployment of District Project Officers, National Disaster Risk Management Programme in six Districts issued in the G.O. first read above.
- 3. After careful examination of the proposal of the Commissioner of Rural Development and Panchayat Raj, the Government cancel the redeployment of District Project Officers, National Disaster Risk Management Programme sanctioned in the

G.O. first read above with effect from 01.07.2009 and also direct that the 6 posts of Assistant Director (NMP) be restored in Tiruvallur, Kancheepuram, Cuddalore, Nagapattinam, Kanniyakumari and the Nilgiris Districts. These posts have already been ordered to be continued upto 30.6.2010 vide G.O.2nd read above.
